



Roadway Closures / Limited Access Armed Forces Cycling Classic Saturday, June 1st

Please be aware that numerous roads will be closed or have limited access Saturday, June 1st, 2024 between the hours of **4:00 AM and 3:00 PM** due to the annual Armed Forces Cycling Classic. Please plan accordingly.

STREET CLOSURES 4:00 AM to 2:00 PM

The following road closures will be in effect:

- 12th ST South from S Elm Street to Crystal Drive
- Crystal Drive from S. 12th Street through S. 15th Street
- 15th ST South EASTBOUND ONLY from Crystal Drive to S Eads Street
- S Eads Street from 15th Street South to Army Navy Drive
- South Clark Street from 12th ST South to 14th Rd South (*limited Access*)
- 11th ST South from S Eads to Army Navy Drive
- Wilson Blvd. from N. Kent Street to the ramp of Route 110
- Route 110 Rosslyn to Crystal City (Closed from approximately 5:00 AM to 11:30 AM only)
- Army Navy Drive from S Eads to 12th ST South (*limited access*)

Impacted Garage Facilities in Crystal City

If your facility/building is not listed here, direct access to parking garage/driveway entrances/exits is not anticipated, however, regional road closures may impact the most direct travel route.

Lenox Club (401 12TH Street South): Access into or out of the parking on 12th ST South will not be accessible between the hours of 4am and 2pm. Please consider alternate FREE overnight parking options for Friday, May 31 at 201 12th ST South underground garage. Delivery services will not have access (consider alternate locations).

Cortland Pentagon City (1221 S. Eads Street): Controlled access across will be in place at S Eads ST at the Main Entrance circle and the parking structure to allow access to 13th ST South. Residents will be required to show IDs at checkpoints at those intersections.

The Point Pentagon City (1201 S. Eads Street): Controlled access across 12th ST South between the parking garage and Army Navy Drive will be maintained throughout the morning. Controlled access across will be in place at S Eads ST at the Main Entrance circle parking area to allow access to 13th ST South. Residents will be required to show IDs at checkpoints at those intersections. Be aware that between 7am and 10am, access across 12th ST South may be delayed.

The Paramount (1425 S. Eads Street): Controlled access across will be in place at S Eads ST at the Main Entrance and the parking structure to allow access at the corner of S Eads ST and 15th ST South. Residents will be required to show IDs at checkpoints at those intersections.

The Bella Vista Condominium (1211 S. Eads Street): Controlled access across will be in place at S Eads ST at the Main Entrance circle and the parking structure to allow access to 13th ST South. Residents will be required to show IDs at checkpoints at those intersections.

Embassy Suites (1393 S. Eads Street): Controlled access across will be in place at S Eads ST at the Main Entrance circle and the parking structure to allow access to 14th ST South. Guests will be required to show IDs at checkpoints at those intersections.

1200 Crystal Drive Access into or out of the parking on Crystal Drive at this location will not be accessible between the hours of 5am and 2pm. Please consider alternate FREE overnight parking options for Friday, June 2nd at 201 12th ST South underground garage. Delivery services will not have access (consider alternate locations).

1400 Crystal Drive Access into or out of the parking on Crystal Drive at this location will not be accessible between the hours of 5am and 2pm. Please consider alternate FREE overnight parking options for Friday, June 2nd at 201 12th ST South underground garage. Delivery services will not have access (consider alternate locations).

Crowne Plaza Hotel (1480 Crystal Drive): Controlled access across 12th ST South between Long Bridge Drive and S Clark Street will be in place. Guest will need to check in with ACPD to cross. Be aware that between 7am and 10am, access may be delayed. After 10am, access will be fairly open.

Water Park Towers (1501 and 1505 Crystal Drive): Be aware of the limited access in this address. Regional road closures will affect the most direct travel routes.

Gateway Condominiums & Waterford House (1200 and 1300 Crystal Drive and 200 12th Street): Access to garages and driveway entrances for these facilities will be maintained. All residents, employees, tenants, and visitors, however, should be informed of the surrounding closures as they may affect the most direct travel routes.

Crystal Square Apartments (1515 Richmond Highway): Be aware of the limited access in the area. This street **will have reduced but available access. May expect some delays in access.**

NOT CLOSED JUST BE AWARE OF IMPACTS TO NORMAL DIRECT ROUTES

1421 Richmond Highway: This location **will not be impacted** by this event. Regional road closures, however, will affect the most direct travel routes.

220 Twentieth Street (220 20th Street): This location **will not be impacted** by this event. Regional road closures, however, will affect the most direct travel routes.

Crystal City Marriott (1999 Richmond Highway): This location **will not be impacted** by this event. Regional road closures, however, will affect the most direct travel routes.

Crystal Gateway 1, 2, 3, and 4 (1235, 1225, 1215 S. Clark Street and 200 12th Street): This location **will not be impacted** by this event. Regional road closures, however, will affect the most direct travel routes.

Crystal Gateway North (201 12th Street): Garage entrances/exits along Long Bridge Drive (formerly Old Jefferson Davis Highway) and 12th Street **will not be impacted** by this event. Regional road closures, however, will affect the most direct travel routes.

Crystal Mall Buildings (1801, 1851, and 1901 S. Bell Street): This location **will not be impacted** by this event. Regional road closures, however, will affect the most direct travel routes.

Crystal Park 1, 2, 3, 4, and 5 (2011, 2121, 2231, 2345, and 2451 Crystal Drive): This location **will not be impacted** by this event. Regional road closures, however, will affect the most direct travel routes.

Crystal Place Apartments and Crystal Park Condominiums (1801, 1805 Crystal Drive): This location **will not be impacted** by this event. Regional road closures, however, will affect the most direct travel routes.

Crystal Plaza Buildings (2100 & 2200 Crystal Drive and 2001 Richmond Highway and the Crystal City Shops @2100 and @2200 Crystal Drive): This location **will not be impacted** by this event. Regional road closures, however, will affect the most direct travel routes.

Crystal Plaza Apartments (2111 Richmond Highway): This location **will not be impacted** by this event. Regional road closures, however, will affect the most direct travel routes.

Crystal Square Buildings (251 and 241 18th Street, 1550 and 1750 Crystal Drive, and 1515 Richmond Highway and the Crystal City Shops @1750): This location **will not be impacted** by this event. Regional road closures, however, will affect the most direct travel routes.
